# Infrastructure Investor Global Summit 2020

The 2019 Infrastructure Investor Global Summit was a significant occasion for the asset class. Over 2000 infrastructure executives came to Berlin over the course of the event, a new record for the industry's largest gathering of institutional capital dedicated to infrastructure.

The event provided the perfect setting for discussions on the impact of disruptive technology and innovation on the future of infrastructure set amid a backdrop of continued global economic and political upheaval.

Once again, the 2020 Summit will be comprised of seven individual forums across four days, covering ESG & sustainability, the energy transition, digital infrastructure, government pipelines, infrastructure debt and much more.

The event features more than 350 speakers, along with a record 550 institutional investors, to stimulate fresh thinking around the way the industry must address the challenges of today and tomorrow.

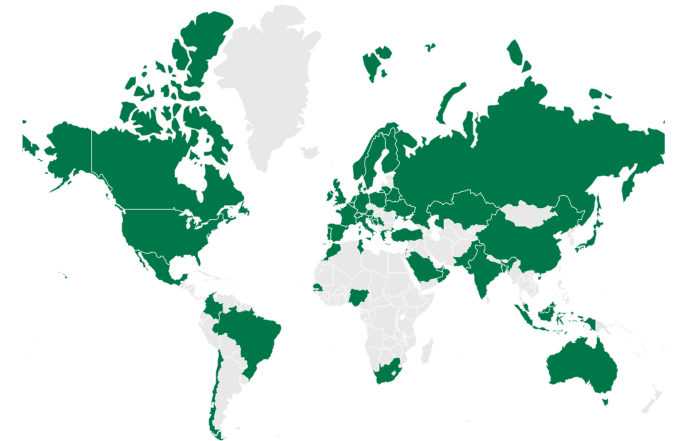

# Highlights from the Global Investor Forum

Over two days, the private infrastructure industry's founders, senior leaders and stars of tomorrow gathered to address the big issues facing the asset class today.



The Forum opened with a fireside chat with Sam Pollock from Brookfield and Guthrie Stewart of PSP Investments. They discussed Brookfield's 'contrarian' approach to investing and the challenges and opportunities of being able to write large equity cheques.



Highlights from the Infrastructure Investor LP Insight survey were followed by analysis, observations and predictions from Ares Management, AP1 and bfinance.



Ben Hammersley, Editor-at-Large, WIRED Magazine gave a keynote address covering AI, cyber terrorists, innovation in an uncertain world and infrastructure assets.

Former NASA astronaut Dr. Garrett Reisman, Director of Space Operations at SpaceX compared public and private sector approaches to innovation. He explained how he uses his NASA experiences to help the private sector manage the risks of space travel.

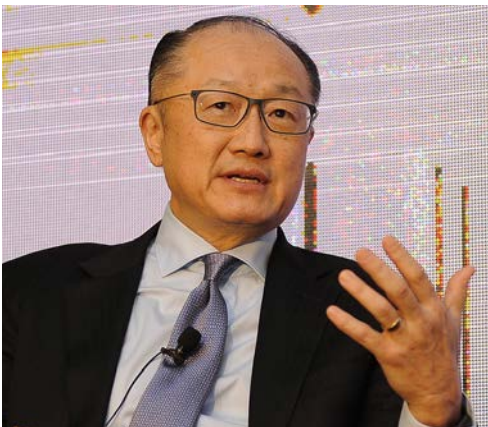


# Highlights from the Emerging Markets, Global Projects and ESG Day

Three forums will open the Global Summit on Monday, covering emerging market opportunities, government project pipelines and why it pays to get ESG & sustainability right in infrastructure. At the 2019 Summit, Monday day concluded with the first public speech from Dr Jim Yong Kim since leaving the public sector for a new role at Global Infrastructure Partners.



Over 200 attendees joined our inaugural ESG & Sustainability Forum discussing topics including building resilience, bridging the SDG gap, ESG in value creation and much more.



Dr Kim, former World Bank President and now Vice Chairman and Partner at GIP, told Bruno Alves, senior editor, Infrastructure Investor, that more creative de-risking is needed to catalyse a wave of private investment in emerging markets.

We raised a toast at the inaugural Emerald Gala Reception, where one champagne glass was loaded with an extra emerald sparkle. We are delighted that the lucky winner from Argo Infrastructure Partners donated the proceeds of the emerald to London's Air Ambulance charity.



The Hon. Monte McNaughton, Minister of Infrastructure for the Province of Ontario, announced that Infrastructure Ontario will roll out its successful P3 model globally.



# Highlights from the Debt, Digital and Energy Transition Day

**Three forums closed the Global Summit on Thursday, focusing on investment opportunities in renewables and the energy transition, the rise of digital infrastructure as an asset class and analysis of different debt investment strategies.**

Philipp Gerbert, Senior Partner & Managing Director, BCG gave a compelling keynote presentation on the economic case for combating climate change.



Sandiren Curthan, PSP Investments and Deepak Agrawal, GIP discussed how GIP & Vena Energy's landmark deal will benefit renewables in Asia while giving insight into investment opportunities in the region.



Sophia Alison, Managing Director, Head of Risk, Macquarie Infrastructure Debt gave a keynote address explaining how to avoid common pitfalls when building an infrastructure debt portfolio.

Marc Ganzi from Digital Colony, one of the first funds to invest in digital, delivered a keynote to a packed room on the opportunity in this exciting sub-sector.

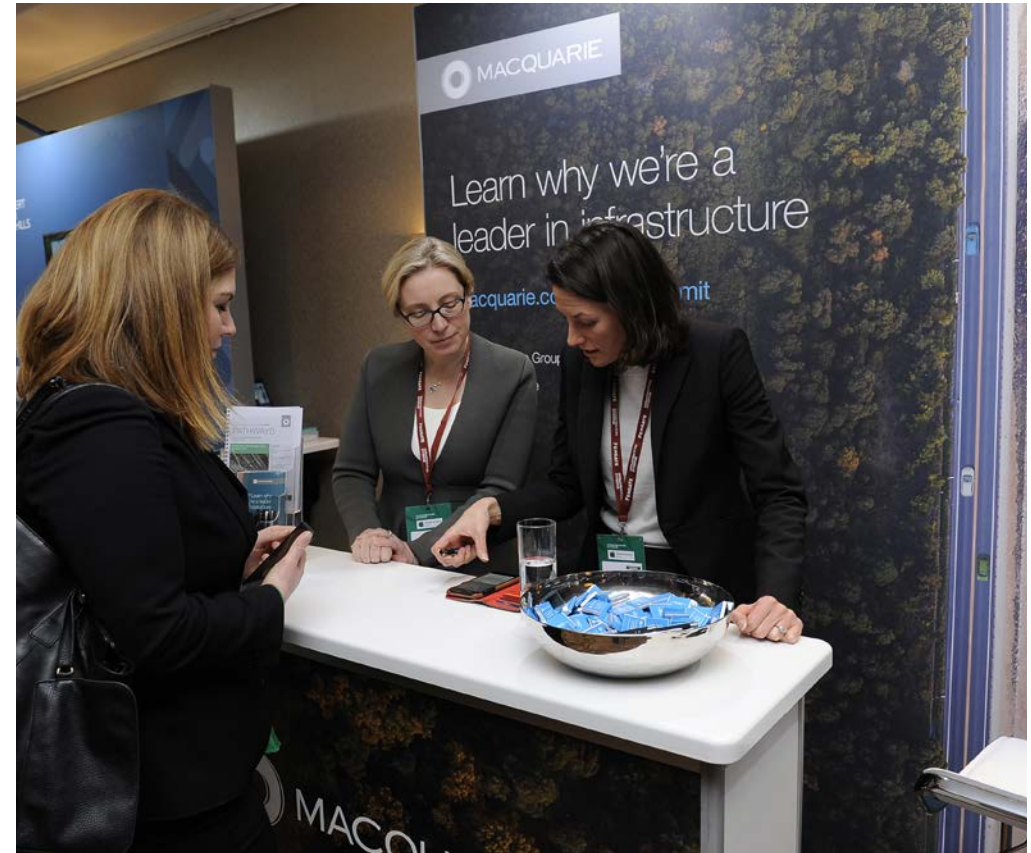
