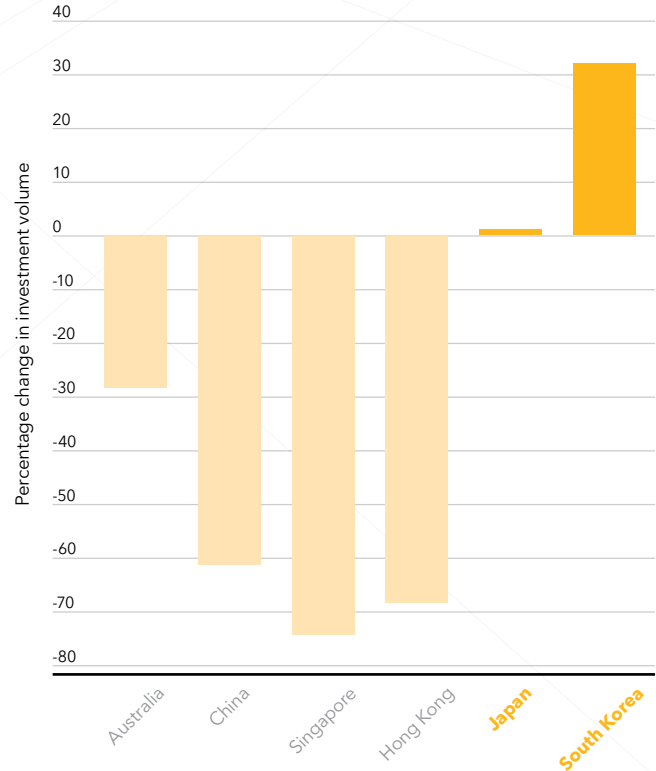
Covid-19's impact on APAC markets

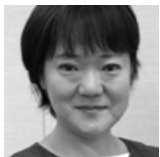
