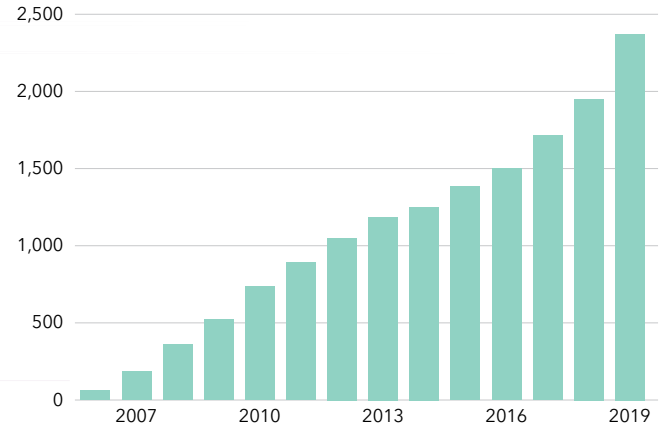
We prefer to build and maintain relationships with asset managers that integrate environmental, social and governance factors throughout the entire investment process.

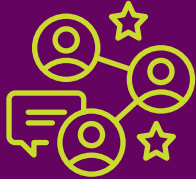

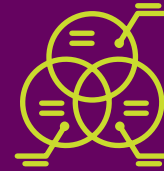
