

### The art and science of leadership with Gillian Tett's anthropological take on business


**Gillian Tett**, *Financial Times*, discussed the art and science of leadership, how we can use anthropology to understand business and so much more.

## Takeaways from the Summit

The Global Summit heard industry leaders analyse the market and set out their roadmaps for the asset class amid the ongoing COVID and Ukraine crises. Markets have undoubtedly been hit by the pandemic and geopolitical events, but the impact on fundraising typically lags behind public markets. Overall, private infrastructure fundraising continues to grow and after a COVID-induced blip in 2020, the market picked itself back up in 2021 with \$136.5 billion of capital raised. Average fund size hit new records driven by megafunds closed in 2021, with an ongoing consolidation being seen over the last five years.
