Expect a tougher fundraising environment next year

The existing surfeit of capital in the asset class could make the fundraising process harder for big and small funds alike.

Investors want a clear rationale for continuation funds

Continuation funds are increasingly popular. Of the billions of Fund manager-led transactions completed in the first half of this year alone, 85% were continuation vehicles.

Democratisation of private equity must be handled carefully

The rising use of technology to bring private equity downmarket could prove a double-edged sword as increased access to private markets creates a need for greater investor protections.
