

# Key highlights from the forum

### Clean Energy Finance Corporation prepares farmland push

Corporations will continuously expand its exposure to the agriculture asset class to create impact and explore how to de-risk returns.

### Institutional investment in the environment is evolving

With the emergence of things like the Principles for Responsible Investment and the UN Sustainable Development Goals, institutional investors have shifted the focus on climate and nature-related thematics as key drivers for growing interest in the asset class.

### **Carbon projects financing**

Most major corporations are now on a trajectory towards net-zero carbon emissions, and that offsetting would inevitably play a role in achieving their goals.

### **Family office strategies**

Family offices are also getting action on carbon projects, such as carbon farming opportunities. Noted deals include Macdoch Group's involvement in the transaction to sell approximately A\$500,000 worth of carbon credits to Microsoft in 2021.

#### Positive outlook for water values

There is an opportunity for water markets over the long term. Supply of water will not increase or sustain the increased natural capital demand for water. In addition, water entitlement prices have not fallen as they have during previous wet periods. This is a sign of increasing market sophistication and maturity.
