We asked **Ron Insana**, the savvy trend-watcher and CNBC some scene-setter questions ahead of the conference which he'll expand on in-person.

What are the uncertainties challenging private equity dealmakers today?

There are three things I'm looking at in 2023 that will present challenges for private equity

1. Interest rates and inflation–Will they both stop going up in 2023? **2. Recession in 2023**–Will it be short and shallow or long and deep?

3. Valuations-How does the economic landscape impact them?

What near-term changes could impact private markets?

Many potential changes could impact private markets, the three at the front of my mind are:

1. Excess liquidity among the biggest players in private

investments crowding out other investors against a backdrop of drying liquidity that was more broadly available prior to 2022.

2. Deglobalization making domestic industries in key sectors more attractive.

3. Geo-political risks (Russia/Ukraine, China/Taiwan) causing massive global economic and political upheaval.
