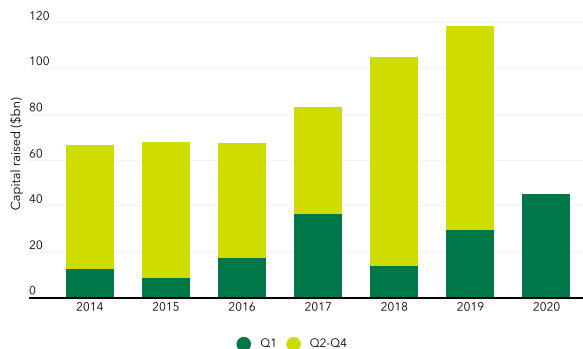

Record-breaking start brings a silver lining in the new era

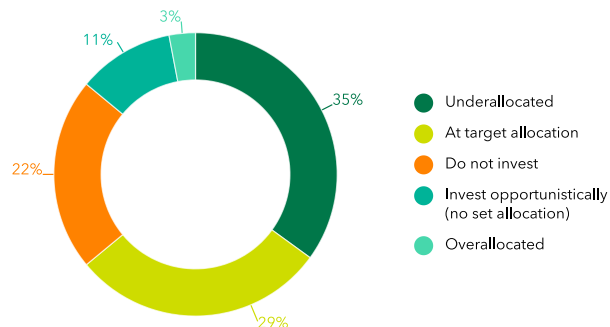

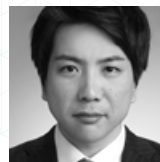
